## Dear Friends,

Thank you for another year of helping our community thrive. As we continue to work towards our mission of a future without poverty, we are thankful to have you walk by our side on this journey, and are pleased to present our accomplishments from the prior year.

Overall, while the total number of people MSC served decreased by three percent last fiscal year; the number of households we served actually increased by three percent. This means we are serving smaller households, and more of them.

We saw the largest growth in our community resource navigation programs with close to 1,000 people receiving one-on-one assistance to connect with community resources and gain access to Coordinated Entry for All in King County.

Due to decreases in participation and some wonderful community partners that provide these services, we decided to discontinue our GED Preparation, English Learning, and Adult Basic Education programs this last year. This shift allows us to focus more on GED services through our Open Doors partnership and develop additional programming focused on youth and young adults.

As I enter my final year serving as CEO, I am proud of all that we have accomplished and thankful to have been able to partner with you to make such an impact in our community. Thank you for your continued support to keep help, hope, and change alive in our community!

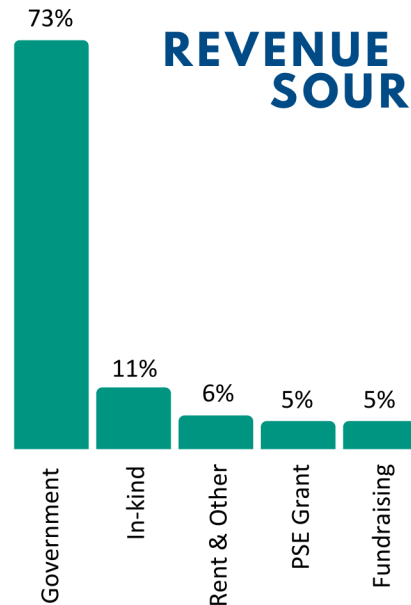

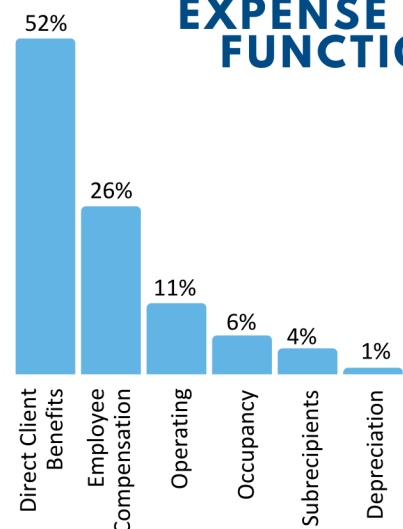

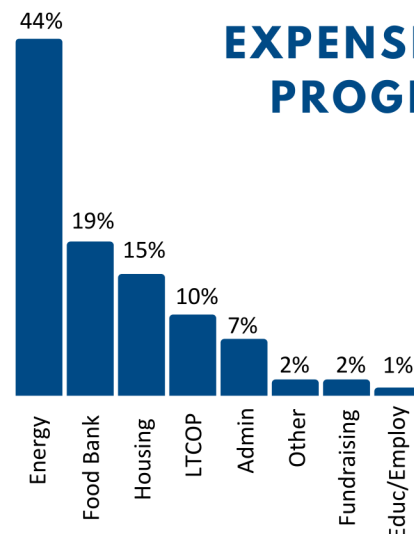
### REVENUE BY SOURCE
